## PROVISION OF REQUESTED INFORMATION

Thank you for your clarified request for information about elephant ivory which we received on 1 November 2016. Your request has been handled under the Freedom of Information Act 2000.

The information you requested and our response is detailed below:

"I would be grateful if you could inform me how many export permits for post 1947 Elephant Ivory have been issued by the U.K. the quantities involved, and the countries to where the Ivory is shipped."

Clarity was then sought over the requested period of time and the items of ivory:

"I request information about RAW Ivory exports over the last ten years."

APHA want to be as open as possible in answering requests. The Freedom of Information Act (FOIA) itself also requires us to help people obtain the information they are looking for. Your request covers information regarding post 1947 elephant ivory between 2006 and 2016. The 2016 data is not yet centrally located and is currently contained on paper application forms. Gathering this specific year together would involve a significant cost and diversion of resources from APHA's other work. To supply you with the requested information for 2016, we would have to examine approximately 20,000 CITES applications to identify whether the item was raw ivory, and post 1947.

Section 12(1) of the FOIA allows us to refuse a request for information if we estimate that the cost of complying with the request would exceed the appropriate limit, which currently stands at £600.

On the basis of our estimates, we consider that to supply the data for the entire requested period (2006 to 2016) would exceed this cost limit and, as such, we are refusing your request as it stands.

However, in accordance with Section 16 of the FOIA, APHA are to provide advice and assistance regarding information requests.

Please see Appendix 1 for the number of 'returned used' CITES re-export permits, for raw post 1947 elephant ivory between 1 January 2006 and 31 December 2015.

The information for 2016 will be centrally located by early 2017 and is due for completion at the end of February.

In addition APHA can advise that all ivory export/re-exports are recorded on the CITES Trade database which can be found here:
