IRAQ HISTORIC ALLEGATIONS TEAM (IHAT) QUARTERLY UPDATE – OCTOBER TO DECEMBER 2014

Overview

Work has continued into providing relevant information to allow the UK government to draft a response to the dossier submitted to the Office of the Prosecutor of the International Criminal Court, in conjunction with the Iraq Historic Allegations Prosecution Team (IHAPT) at the Service Prosecution Authority (SPA).

This quarter saw three deployments of the specialist Achieving Best Evidence (ABE) interview teams.. Video interviews with 30 witnesses were obtained.

The IHAT has conducted initial investigative assessments of approximately 800 additional cases provided by Public Interest Lawyers (PIL) and Leigh Day and Company (LDC) since Jul 14. The results of the LDC cases were forwarded on 18 Sep 14 to Provost Marshal Navy, advising the IHAT investigate a further 174 cases. The direction to do this has now been received.

IHAT current strategic objectives:

- Allegations of unlawful killings in the custody/care/control of British Forces
- Allegations of the unlawful killings of juveniles
- Allegations of unlawful killings outside of custody
- Allegations of serious ill-treatment including GBH, rape, sexual assault
- Allegations of ill-treatment that may meet the war crimes threshold
- Allegations of ill-treatment not meeting war crimes threshold

Cases allocated to IHAT

The tables below detail IHAT cases and show at which stage those cases are in the IHAT preinvestigation and full investigation process.

As of 05 Jan 15, the IHAT has been assigned **252** cases involving **432** victims. For the purposes of this report an IHAT case refers to a single victim or group of victims which maybe known or unknown, whilst a victim refers to a single individual against whom an alleged crime(s) was committed. This caseload comprises of 197 cases of alleged III Treatment involving 366 victims of the IHAT current caseload. The remaining 55 cases are allegations of unlawful killing comprising of 66 victims. In Nov 14, 88 cases involving 153 victims were added to the IHAT caseload.

PREDICTED IHAT CASELOAD

Other allegations of unlawful killing and ill treatment have been sent to the IHAT by PIL which are still being assessed. These cases have not yet been forwarded as they are still being analysed. In addition other potential victims have come to light as a result of ongoing investigative activity and are currently subject to initial analysis


For these reasons, the cases known to the IHAT have been subdivided into six categories in order to help improve the case management process. These categories are summarised in the table below:

If all the cases outlined above are endorsed, it is estimated that the total IHAT caseload will comprise 1331 victims. A breakdown of this figure by Caseload can be found in Figure 2 below:

STATUS OF CURRENT IHAT CASELOAD

Allegations of Unlawful Killing

This Strategic Overview therefore focuses on IHAT Caseload 1. The IHAT is still waiting for further details of the nature of the criminal allegations made within civil private law claims in Caseload 2 from the originating complainant via their legal representative.

There are currently 36 allegations of unlawful killing at the Pre-Investigation stage of the IHAT process this represents 56% of all the unlawful killing allegations in Caseload 1. This means that 28 (44%) of unlawful killing allegations in Caseload 1 have passed through Pre-Investigation.

So far seven (11%) of the unlawful killing allegations in Caseload 1 have been closed following Pre-Investigation. This means that 75% of allegations are currently being accepted by the IHAT for full or directed investigation.

If this trend continues, it would be expected that 27 of the 36 allegations still left in the Pre-Investigation phase would be accepted for full or directed investigation by the IHAT. However, the initial cases involve death in custody or in contact with UK Armed Forces. Therefore, future cases may lead to fewer proceeding to a full investigation.

The 28 (44%) allegations of unlawful killing in Caseload 1 are currently being assessed by the IHAT, with a further seven (11%) being considered in preparation of being assessed by the Joint Case Review Panel (JCRP).

Allegations of III Treatment

There are 165 allegations of ill treatment at the Pre-Investigation stage of the IHAT process which represents 77% of all ill treatment allegations in Caseload 1. This means that 50 (23%) of ill treatment allegations in Caseload 1 have passed through Pre-Investigation.

There are seven (3%) cases which have been assigned to have a Problem Profile developed by the IHAT in order to direct forthcoming multiple case Investigations.

To date there are four (2%) ill treatment allegations in Caseload 1 that have been closed following Investigation. A further 39 (18%) allegations of ill treatment are currently subject of IHAT investigations.

There are currently 103 (48%) victims from Caseload 1 who are to be interviewed, with a further 52 (24%) awaiting initial assessment.
