I am writing in response to your request for information regarding the below received on 12 November 2015. Your request has been handled under Section 1(1) of the Freedom of Information Act 2000. In accordance with Section 1(1) (a) of the Act I hereby confirm that the CNC/CNPA does not hold information of the type specified. The answer to all of the below are zero.

I would like to find out details about payments to celebrities for the financial years 2012/13, 2013/14 and 2014/15 - I would like to know: * the name of every celebrity who received payment by the force; * the amount they were paid; * what service / responsibility they carried out; * where and when the event took place.

This can be returned as an itemised list. For example: 1 Ken Stott; £2,500; after dinner speaker; force Christmas party, December 2010. 2 Frank Skinner; £10,000; presenting awards; end of year awards ceremony, March 2012.

For the purposes of this request, the term "celebrity" can be defined as somebody of local, national or international note or fame. They can include a sportsman - ie for a local football team - a reality television personality or politician. Local politicians (i.e. town council or the mayor) should not be considered celebrities.

Payments to MPs should be included. Where celebrities have been paid through agents or companies, please make this clear in the return. It may be that the force has not made any payments in this way. Please state this, if so.

The Civil Nuclear Constabulary is a specialist armed police service dedicated to the civil nuclear industry, with Operational Policing Units based at 11 civil nuclear sites in England, Scotland and Wales and over 1400 police officers and staff. The Constabulary headquarters is at Culham in Oxfordshire. The civil nuclear industry forms part of the UK's critical national infrastructure and the role of the Constabulary contribute to the overall framework of national security.

The purpose of the Constabulary is to protect licensed civil nuclear sites and to safeguard nuclear material in transit. The Constabulary works in partnership with the appropriate Home Office Police Force or Police Scotland at each site. Policing services required at each site are agreed with nuclear operators in accordance with the Nuclear Industries Security Regulations 2003 and ratified by the UK regulator, the Office for Nuclear Regulation (ONR). Armed policing

services are required at most civil nuclear sites in the United Kingdom. The majority of officers in the Constabulary are Authorised Firearms Officers.

The Constabulary is recognised by the National Police Chiefs' Council (NPCC) and the Association of Chief Police Officers in Scotland (ACPOS). Through the National Coordinated Policing Protocol, the Constabulary has established memorandums of understanding with the local police forces at all 11 Operational Policing Units. Mutual support and assistance enable the Constabulary to maintain focus on its core role.

We take our responsibilities under the Freedom of Information Act seriously but, if you feel your request has not been properly handled or you are otherwise dissatisfied with the outcome of your request, you have the right to complain. We will investigate the matter and endeavour to reply within 3 – 6 weeks. You should write in the first instance to:
