Summary

Within the local area of the proposed UTC, it is expected that 3 schools will feel a high impact, 6 schools will feel a moderate impact, and 6 schools will feel a minimal impact. The schools with a high impact rating are The Phoenix Collegiate, Holly Lodge Foundation High School College of Science and Ormiston Sandwell Community Academy.

The Phoenix Collegiate is only 1.2 miles from the proposed UTC site and, in principal, the school is likely to lose more pupils to the new UTC than schools further away. Additionally, it has attainment below the national average and was judged Requires Improvement by Ofsted in 2013, so parents and pupils may be attracted to an alternative school. The school was undersubscribed for entry in 2012 and had an overall surplus of places of 846. The loss of even a few pupils could exacerbate the existing surplus issue in this school and there could be a significant impact on the school's overall attainment, viability and ability to improve.

Holly Lodge Foundation High School College of Science is 1.7 miles from the proposed UTC site and, in principal, the school is likely to lose more pupils to the new UTC than schools further away. Additionally, it has attainment below the national average, so parents and pupils may be attracted to an alternative school. The school was undersubscribed for entry in 2012 and had an overall surplus of places of 336. The loss of even a few pupils could exacerbate the existing surplus issue in this school and there could be a significant impact on the school's overall attainment, viability and ability to improve.

Ormiston Sandwell Community Academy is 1.9 miles from the proposed UTC site and, in principal, the academy is likely to lose more pupils to the new UTC than schools further away. Additionally, it has attainment below the national average and was judged Requires Improvement by Ofsted in 2013, so parents and pupils may be attracted to an alternative school. The school was undersubscribed for entry in 2012 and had an overall surplus of places of 182. The loss of even a few pupils could exacerbate the existing surplus issue in this school and there could be a significant impact on the school's overall attainment, viability and ability to improve.

It is unlikely that any negative impact on these three schools will be mitigated by an increased demand for school places in the local area as the LA District school population in the 14-19 age range is projected to remain relatively stable over the next few years.
