









CALL FOR EXPRESSION OF INTEREST TO ATTEND **DFID Zimbabwe and Leading Programme Partners Supplier Briefing Seminar** To be held on Wednesday 27th January 2016, at the Celebration Centre, Harare

The Department for International Development (DFID), as part of the UK Government, leads the UK's work to end extreme poverty. It does this by creating jobs, unlocking the potential of girls and women and helping to save lives when humanitarian emergencies hit.

DFID has come together with some of its key partners to provide the opportunity for Small & Medium Enterprises in Zimbabwe to hear more about the work DFID and its partners undertake in Zimbabwe and other parts of the world and to have the opportunity to meet implementing partners on a 1:1 basis. It is also a chance to receive some 'capacity-building' support to assist in being able to support DFID and partner led development programmes.
