### Making it easier to contact DIO

Two new contact lists have been created to help customers and members of the public contact DIO for services or to request information.

### **DIO Strategic Business Partner update**

DIO continues to make progress with the procurement of a Strategic Business Partner (SBP) and after announcing Capita (working with URS and PA Consulting) as the Preferred Bidder. The idea is that the SBP will be able to inject further specialist resources to help DIO perform even better.

Whilst Capita has not yet been awarded contract it is expected the Department will move to contract award during late spring.

A Defence Infrastructure Governance Authority (DIGA) stood up on 1 April 2014. This body is part of the DIO and will oversee the activity of the SBP. During mobilisation they will ensure that the SBP has met all criteria and targets before the contract can go live.



# About NGEC

This first tranche of contracts has been awarded and include the National Housing Prime contract (NHP). The contract, which is valued at £626m, has been awarded to CarillionAmey (Housing Prime) Ltd.

Again, for the time being there are no changes, but DIO and CarillionAmey will keep you informed, to ensure that you understand the transition arrangements, and how the contracts are different from the existing contracts. In service dates and any changes to contact details will be promoted in advance to ensure that you can continue to access DIO services.

## **NHP** - what happens now?

Until advised otherwise, customers should continue to ring the normal telephone numbers and use the existing email addresses - the usual contact details are above right and continue to be published on the SFA website and contractor's website.

A great deal of work has already been undertaken to plan for a smooth transition to the new contract later this year. Now that the contract has been awarded, the new contractor will now begin a period of mobilisation to prepare for the introduction of the new arrangements.

At the same time each existing contractor will be preparing for demobilisation, to ensure that the existing contracts and work are correctly brought to a close, with relevant information and equipment returned or transferred.

# The next generation of housing support

DIO continues to change with the aim of improving the way it supports infrastructure for people in Defence, and to support defence capability. DIO has now taken a huge step forward in these efforts, with the award of contracts valued at £1.1 billion for the Next Generation Estate Contracts (NGEC).

> The new housing contract will not come into effect until late 2014, so for the time being there are no changes. However, information about the contract is below. <

# A brief introduction to the **National Housing Prime**

The NHP will be a UK wide contract, so it will replace existing contract arrangements to support Service Family Accommodation in England and Wales, and separate arrangements in Scotland and Northern Ireland. This contract has greater scope than previous maintenance contracts, as it provides additional services for managing move-in, move-out services, housing allocations and the installation of furniture and fittings.

The intention is that a new IT system will give customers improved access to services, such as the ability to report maintenance issues online.

The NHP will be implemented through a phased mobilisation programme by December 2014, although some elements will continue into 2015.
