FREEDOM OF INFORMATION ACT 2000 REQUEST REF: 0774-15

Thank you for your letter of 29 July requesting information on the Locally Engaged Iraqi Staff – Direct Entry Assistance Scheme under the Freedom of Information Act (FOIA) 2000. You asked:

- 1. What information was given to those who previously qualified under the Scheme regarding its termination?
- 2. What information was available in the public domain regarding its termination?
- 3. Where was this information published?

I am writing to confirm that we have now completed the search for the information which you requested. I can confirm that the Foreign and Commonwealth Office (FCO) does hold information relevant to your request.

1. What information was given to those who previously qualified under the Scheme regarding its termination?

On 23 March 2009, the then Foreign Secretary, David Miliband, announced that the Locally Engaged Iraqi Staff - Direct Entry Assistance Scheme would close for any 'former staff' who qualified under the scheme. On 16 September 2010, the then Foreign Secretary, William Hague, announced that the scheme would close for 'serving staff' who gualified under the scheme. Under section 21 of the FOI Act, we are not required to provide information in response to a request if it is already reasonably accessible to you. This is an absolute exemption and so the Public Interest Test does not apply. The information can be found on Hansard, the edited verbatim report of proceedings of the House of Commons and the House Lords, of at the following address: http://www.parliament.uk/business/publications/hansard/. After the announcements in 2009 and 2010, this information, along with contact details for those wishing to apply, was communicated in official FCO press releases - copies are included as annexes to this letter.

2. What information was available in the public domain regarding its termination?

The written Ministerial statements referred to above. In addition, the FCO issued press releases on both occasions containing this information, along with contact details for those wishing to apply.

3. Where was this information published?

The Ministerial statements were published in Hansard and the FCO issued press releases.

Once an FOI request is answered, it is considered to be in the public domain. To promote transparency, we may now publish the response and any material released on <u>gov.uk</u> in the <u>FOI releases</u> section. All personal information in the letter will be removed before publishing.

The information supplied to you continues to be protected by the Copyright, Designs and Patents Act 1988.
