**For the years 2011 to 2015, broken down by each year and by each hate crime category, the total number of racist, religious (faith), homophobic, transgender, disability, and islamophobic hate crime offenders proceeded against by way of cautions.**

**For the years 2011 to 2015, broken down by each year and by each hate crime category, the total number of racist, religious (faith), homophobic, transgender, disability, and islamophobic hate crime offenders proceeded against by way of community resolutions.**

**For the years 2011 to 2015, broken down by each year and by each hate crime category, the total number of racist, religious (faith), homophobic, transgender, disability, and islamophobic hate crime offenders proceeded against by way of youth cautions or youth triage”.**

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate the case until the MOD internal review process has been completed.
