Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

I can confirm that the Department holds the information that you have requested, however, under Section 40(2) – Data Protection which applies to personal data relating to third parties, the release of all of the information you have requested relating to other individuals would contravene the principles of the Data Protection Act 1998. These principles are Principle 1 – personal data shall be processed fairly and lawfully and not unless certain specified conditions are met, and Principle 2 – personal data shall be obtained and processed only for specified and lawful purposes and not further processed in a manner incompatible with the purposes. In this instance, data has been provided for appointment purposes and not with the expectation that it would be made public.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
