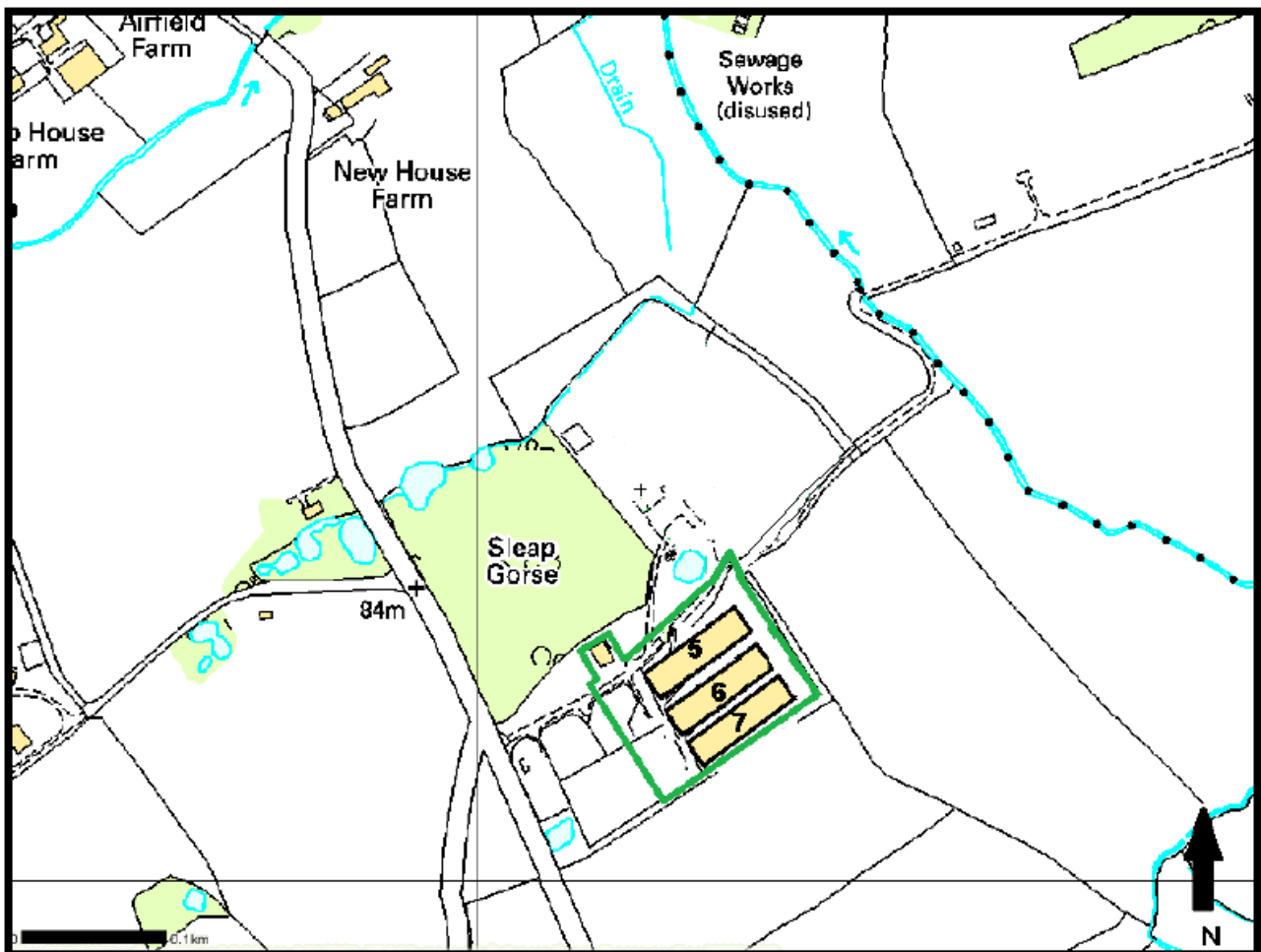
The installation boundary plan in Schedule 7 as referenced in condition 2.2.1 has been amended as a result of the part surrender.
