

Notice to the Office of the Public Guardian of an objection to registration of an enduring power of attorney

You use this form to tell the Office of the Public Guardian (OPG) about your objection to the Court of Protection ('the court') regarding an enduring power of attorney (EPA) registration. OPG and the court are different organisations. You need to tell OPG within 35 days of the date you are sent an EP1PG form, which tells you an EPA is going to be registered. If you don't tell OPG, it may go ahead and register the EPA.
