PROVISION OF REQUESTED INFORMATION

Thank you for your clarified request for information about chimpanzee imports to Wingham Wildlife Park, which we received on 20 April 2016. Your request has been handled under the Freedom of Information Act 2000.

The original information you requested and our response is detailed below:

“I am writing to request a copy of all submissions made by the Wingham Wildlife Park in Kent, England, concerning their request to import eight chimpanzees from the Yerkes National Primate Research Center in Atlanta, Georgia.”

Clarity was then asked and you responded:

“I am requesting any and all applications and any and all permits and draft permits that you are allowed to send me.”

Please find attached at Appendices 1 to 3 the applications and draft permits made by the Wingham Wildlife Park concerning their request to import eight chimpanzees from the Yerkes National Primate Research Center, in June 2015.

APHA issued these draft permits which were not valid for use, and we would only issue the useable versions after the US Fish and Wildlife had issued their export permits.

Personal information has been redacted from all applications and draft permits. Section 40(2) of the Freedom of Information Act provides that personal data relating to third parties is exempt information if disclosure would breach the Data Protection Act 1998 (DPA).

APHA consider that disclosure of this information is likely to breach the first data protection principle in Schedule 1 to the DPA, which relates to the fair and lawful processing of personal data, in two ways. First, disclosure would not constitute ‘fair’

processing of the personal data, second, disclosure would not satisfy any of the conditions for data processing set out in Schedule 2 to the DPA. Therefore, we have concluded that this information is exempt from disclosure.

Information disclosed in response to this EIR/FOI request is releasable to the public. In keeping with the spirit and effect of the EIR/FOIs and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
