

NOTICE OF GROUND INVESTIGATION SURVEYS



As part of developing the route design of the HS2 high speed railway, we are carrying out ground investigation surveys on **Park Village East, Mornington Street, Granby Terrace, Harrington Street and Hampstead Road.**

Our contractor will be taking samples of the road surface and the soil conditions underneath the road and/or pavements to check their condition using a variety of drilling methods. As a result we will need to temporarily suspend a number of parking bays or cone parts of the roads and pavements for the safety of workers. Where work is required in a bus lane, work will be carried out in the evening.

Please note that all dates below may be subject to minor change, dependent on ground conditions uncovered along the routes.

Park Village East:

Between 6 June and 24 June

- Carriageway and footpath closure opposite Nash House and 1 permit holder parking bay suspended.
- Opposite rear gate of 36 Park Village East three parking bays (two permit holder and 1 pay-by-phone) suspended

Between 27 June and 1 July

- Two permit holder bays suspended outside 14 and 16 Park Village East

Continued 1/4

Between 6 June and 12 August

- Three permit holder bays suspended outside 12 Park Village East
- Four permit holder bays and one motorcycle parking bay suspended north of the junction with Mornington Street and carriageway lane closure

Please note that parking bay suspensions will be kept to a minimum during the time periods stated, will not take place at the same time and will be brought back into use as soon as possible.

Some of the work in Park Village East had originally been scheduled to take place during March but was unfortunately delayed. We apologise for this earlier postponement.

Mornington Street:

Between 27 June and 1 July

- Carriageway part-closure east of Mornington Terrace junction

Granby Terrace:

Between 27 June and 1 July

- Two permit holder parking bays suspended on northern side of Granby terrace at Park Village East junction
- Two pay by phone parking bays suspended at Hampstead Road junction

Between 13 June and 5 August

- One permit holder parking bay suspended on southern side at junction with Stanhope Street

Harrington Street:

Between 6 June and 1 July

- Three permit holder parking bays suspended at junction of Mackworth Street
- Road closure but residents' access remains throughout

Between 31 May and 12 August

- Two permit holder parking bays suspended at junction of Granby Terrace
- Road closure but access to garages remains throughout

Please note that parking bay suspensions will be kept to a minimum during the time periods stated, will not take place at the same time and will be brought back into use as soon as possible.

Work on all the above takes place between 8:00 and 18:00 Monday to Friday only.

Hampstead Road:

Between 4 July and 8 July from 19:00 to 23:59

- Bus lane closure from Harrington Square southbound
- Bus lane closure north of Granby Terrace northbound
- Bus lane closure outside 1-67 Cartmel northbound and southbound

How will this affect me?

Some of the drilling can be a little noisy due to the type of plant required. The majority of this noisier work will be restricted to daytime hours Monday to Friday. Some parking bays as indicated above will be temporarily suspended. Along Hampstead Road, surveys are needed within bus lanes. Work in these locations will be carried out in the evenings from 19:00 – 23:59 when the bus lane restrictions are lifted. This will allow adequate traffic management to be installed to protect workers and ensure traffic flow is maintained throughout.

Once work is complete in all locations, our contractor will restore the area as soon as possible. Public and residential access will be maintained along all affected footpaths and roads. At different times, traffic management systems may be in place to accommodate the work. Our contractor will work as quickly as they can, avoid unnecessary noise and keep the area tidy.

We apologise for any disturbance but would like to assure you that these are relatively minor operations and should not be particularly disruptive.

Ground investigation surveys help us to understand the ground conditions where the railway route is proposed or near to where stations are located.
