Thank you for your email of 2 September in which you requested the following information:

1. For 2013, 2014 and 2015 (up to September 2) can you please state how many servicemen and women based in Scotland have been tested for the use of illicit drugs per year?

2. For each instance relating to question 1 above can you please state whether the test yielded a positive or negative result in terms of illicit drugs in the system? 3. For each instance relating to question 1 above can you please state where that test took place?

4. For each instance relating to question 1 above can you please state which of the armed forces the serviceman or woman involved was with at that time? 5. For each instance relating to question 1 above can you please state where that serviceman or woman was based and name the regiment or section they were part of? 6. For each instance relating to question 1 above can you please state if the serviceman or woman was dismissed as a result of the drugs test outcome?

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). A search for the information has now been completed, and I can confirm that information is held which falls within the scope of your request.

The Ministry of Defence has a policy of Compulsory Drug Testing, which seeks to reinforce the message that drug use is unacceptable in Service personnel. The Armed Forces do not tolerate any form of inappropriate behaviour including substance misuse. Where an individual is found, through compulsory drug testing or other investigation, to have fallen short of the Services' high standards, they will be dealt with through the military discipline or administrative process. The information is presented in the tables below broken down by Service.

ROYAL NAVY

The figures for the Royal Navy in the table below also include personnel serving in the Royal Marines. In regard to Q3, tests were conducted at Faslane, Arbroath and Rosyth.

We are withholding the section or regiment and base of each individual as that would likely compromise their identity in view of the low numbers of positive tests. Its release is governed by the Data Protection Act in order to ensure individual identities are not revealed inadvertently.

ARMY

For the Army, in 2013, 7,180 tests were conducted of which there were 50 positive results. In 2014, 6,260 tests were conducted of which there were 40 positive results, and in 2015 (at as 31 July) 3,230 tests were conducted of which there were 20 positive results. In regard to Q6, data is not held in terms of discharges by location of Regiment.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
