Thank you for your email of 27 September 2016 requesting the following information:

"Could you please provide the answers for the 5 questions below relating to Facilities Management contracts for the Department along with its Executive Agencies & Public Bodies.

- (1) Does the Department/Executive Agency outsource any property services and Facilities Management to a third party?
- (2) For Facilities Management contracts, could you state whether those are soft FM, hard FM or Total FM contracts?
- (3) Could you provide the year of the contract's expiry?
- (4) Could you provide the annual £ value of the contract?
- (5) Could you state the provider of the contract? For example MITIE"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held.

The information you have requested can be found enclosed annex A but some of the information falls entirely within the scope of the absolute exemptions provided for at Section 40 (Personal Data) and has been redacted, withheld. The contract values stated are for the full contract value unless otherwise stated, we are unable to separate Facilities Management costs only.

Section 40(2) has been applied to some of the information in order to protect personal information as governed by the Data Protection Act 1998. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 2<sup>nd</sup> Floor, Zone N, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
