**Request for Information**

Thank you for your email of 27 November 2014 requesting information on GO-EAST. For ease of reference your request was for *“a copy of the non-redacted progress return submitted to GO-EAST for the period ending 31st December 2008 from Eastport UK in respect of ERDF funding supporting the Great Yarmouth Outer Harbour Development.”*

We have now had an opportunity to investigate your request and are writing to communicate our response.

**Information not held**

We can confirm that we do not hold the information requested. By way of background information, the Department for Communities and Local Government (DCLG) were the lead department for the Government Offices (GO). Therefore, upon the closure of the GOs (in this instance, GO-EAST), we understand their records will have been transferred to DCLG and as a result the Homes and Communities Agency do not hold the records related to your request.

We do, however, hold one report regarding the Evaluation of Outer Harbour Project, prepared by PricewaterhouseCoopers. We provide this in full, without redaction. Although this is not the document you requested, we hope that it is of some value to you.
