Thank you for your email of 21 June and further email of 22 July in which you clarified that in relation to questions one to five you were requesting information for the period 2005-2015. Your request is therefore seeking the following information:

- Q1 - The number of personnel serving in the QARANC as Registered Nurses 2005 – 2015.
- Q2 - The number of Commissioned Officers (Registered Nurses) serving in the QARANC 2005 – 2015.
- Q3 - The number of ethnic minority Commissioned Officers (Registered Nurses) serving in the QARANC 2005 – 2015.
- Q4 - The number of QARANC Student nurses at DSHE/DHE (BCU) for the period 2005 – 2015.
- Q5 - The number of ethnic minority QARANC Student nurses at DSHE/DHE (BCU) for the period 2005 -2015.
- Q6 - The number of Army Nursing Officer commissioning applications made by students whilst at DSHE from 2005 – 2015, resulting in a place at RMAS.
- Q7 - The number of Army Nursing Officer commissioning applications made by ethnic minority students whilst at DSHE from 2005 – 2015, resulting in a place at RMAS.
- Q8 - The total number of officers that have formed AOSB (Briefing) and AOSB (Main Board) boards between 2005 – 2015.
- Q9 - The total number of ethnic minority officers that have formed AOSB (Briefing) and AOSB (Main Board) boards between 2005 – 2015.
- Q10 - The total number of ethnic minority officers that have formed AMS AOSB boards between 2005 – 2015.

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of some of your request is held. The information you requested is attached.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
