# The Merchant Shipping (Small Workboats and Pilot Boats) (Amendment) Regulations 2015

The Secretary of State, in exercise of the powers conferred by sections 85(1)(a) and (b), (3) and (5) to (7) and 86(1) of the Merchant Shipping Act 1995(a), and having consulted the persons referred to in section 86(4) of that Act, makes the following Regulations:

**1.** These Regulations may be cited as the Merchant Shipping (Small Workboats and Pilot Boats) (Amendment) Regulations 2015 and come into force on [XXXX 2015].

**2.** The Merchant Shipping (Small Workboats and Pilot Boats) Regulations 1998(**b**) are amended by substituting the table in the Schedule to these Regulations (which contains a list of Regulations relating to safety of vessels which are not to apply to small workboats and pilot boats subject to their complying with a relevant Code of Practice) for the table in the Schedule to those Regulations.
