



Causes of concern in opened investigations 2015 to 2016


Note that most cases involve more than one issue. Baseline: 53 investigations



Causes for concern in closed investigations 2015 to 2016





5. Reported concerns about charities 2015 to 16

5.1 Reports of serious incidents (RSIs)

There were 2,217 serious incidents reported to us in 2015 to 16 (2014 to 15: 2,129). The key issues in these reports were as follows, showing the principal issue only.

We engaged with charities that had previously reported serious incidents, to seek assurances that they have since acted on the regulatory advice we had given. Of the serious incidents reported to us, 1928 were dealt with solely by our customer facing team, First Contact, 36 referred to our investigations team, and 249 to our operations team.

5.2 Whistleblowing reports

We dealt with 143 whistleblowing enquiries this year (2014 to 15: 114). They fall into 3 source categories

- 15 from auditors (2014 to 15: 18)
- 41 from independent examiners (2014 to 15: 46)
- 87 from employees: (2014 to 15: 50)

As a result we opened 85 cases of which 16 are still active, 1 resulted in a statutory inquiry, and 3 in action plans. Of Whistleblowing cases, 87 were referred to us by employees, 15 by an auditor and 41 by independent examiners. Of these cases, 41 were dealt with solely by our First Contact team, 5 went to our investigations team, 95 to our operations team, of which 2 were monitoring cases.
