I am writing in response to your request for information regarding the below received on 12 February. Your request has been handled under Section 1(1) of the Freedom of Information Act 2000. In accordance with Section 1(1)(a) of the Act I hereby confirm that the CNC/CNPA does hold information of the type specified.

- **Name of financial accounting software system in use in your organisation**

SAP R4.7

- **Original date of purchase (financial accounting software)**

2004 by United Kingdom Atomic Energy Authority

- **Cost of annual support and maintenance for the financial accounting software system (last financial year)**

Total cost unknown as CNC pays a small share of this cost and CSC (outsourced) support costs are not unbundled from the overall IT contract.

- **Other annual spend relating to the financial accounting software system, outside the support and maintenance costs**

There is a separate invoice processing system costing around £25k pa

- **Number of members of staff involved in the internal support of the financial accounting software system for users and IT**

CNC support for SAP is outsourced to CSC hence the internal support team is approximately 2 FTE.

We take our responsibilities under the Freedom of Information Act seriously but, if you feel your request has not been properly handled or you are otherwise dissatisfied with the outcome of your request, you have the right to complain.
