Thank you for your email of 21 April 2016 requesting the following information:

"Could you please provide with names and locations of the MOD bases in the Midlands area. Could you please give me the name of the Estates Manager for each location and their telephone and email contact details."

Section 40(2) has been applied to some of the information in order to protect personal information as governed by the Data Protection Act 1998. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note we have defined the following counties as "the Midlands" - The West Midlands, Staffordshire, Shropshire, Hereford and Worcester, Warwickshire, Northamptonshire, Nottinghamshire, Leicestershire, Rutland, Derbyshire and Cambridgeshire.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 2nd Floor, Zone N, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
