Thank you for your email of 20 October 2015 requesting the following information.

- "1. What is the total budget in pounds sterling for the 'With Heart, With Mind' Army recruitment campaign which is involving a tour of UK universities?
- 2. How many universities will be visited, and which ones are they?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held. The information you requested is shown below.

1. What is the total budget – in pounds sterling – for the 'With Heart, With Mind' Army recruitment campaign which is involving a tour of UK universities?

The budget for recruiting year 15/16 is £2.4m. This budget incorporates spending on all officer recruiting activity under the banner of "With Heart, With Mind", including not only advertising costs, but all assets, media and use of trucks on university campuses.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
