Section 12(1) of the Justice and Security Act 2013 ("the Act") requires the Secretary of State to prepare (and lay before Parliament) a report on the use of the closed material procedure (CMP) under section 6 of that Act. Under section 12(4) of the Act, the report must be prepared and laid before Parliament as soon as reasonably practicable after the end of the twelve month period to which the report relates.

The report is submitted in the form of the tables below. The first set of tables ("Applications", "Declarations", "Revocations", "Final Judgments") lists numbers, as prescribed by section 12(2) of the Act. The second set of tables ("Additional Information") provides the names of the cases referred to in the first set; this additional information is provided at the discretion of the Secretary of State under section 12(3) of the Act.

This is the third annual report on this subject and covers the period from 25 June 2015 to 24 June 2016.

This judgment was on an appeal against a decision to make a CMP declaration under section 6 Justice and Security Act 2013 in the previous reporting period. The substantive proceedings have now been withdrawn following a Notice of Discontinuance served on 24 June 2016.

There were two open judgments in the reporting period 25 June 2015 to 24 June 2016 (that is, the Court of Appeal decision of 14 July 2015 and the Supreme Court decision of 8 December 2015), both concerning an appeal against a decision to make a CMP declaration under section 6 Justice and Security Act in a previous reporting period.

Following the CMP declaration, there was a successful application to strike out the claims. That order is currently the subject of an appeal; the judgment thereon is expected to be included in the next annual report.
