This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpaths described in paragraph 1 of this Order it is expedient that the paths should be diverted.

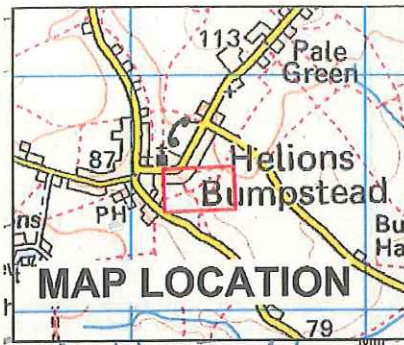
The applicant has agreed to defray the expenses incurred in the order making and any expenses which are incurred in bringing the new site of the paths into a fit condition for use by the public.

Braintree District Council has been consulted and has consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

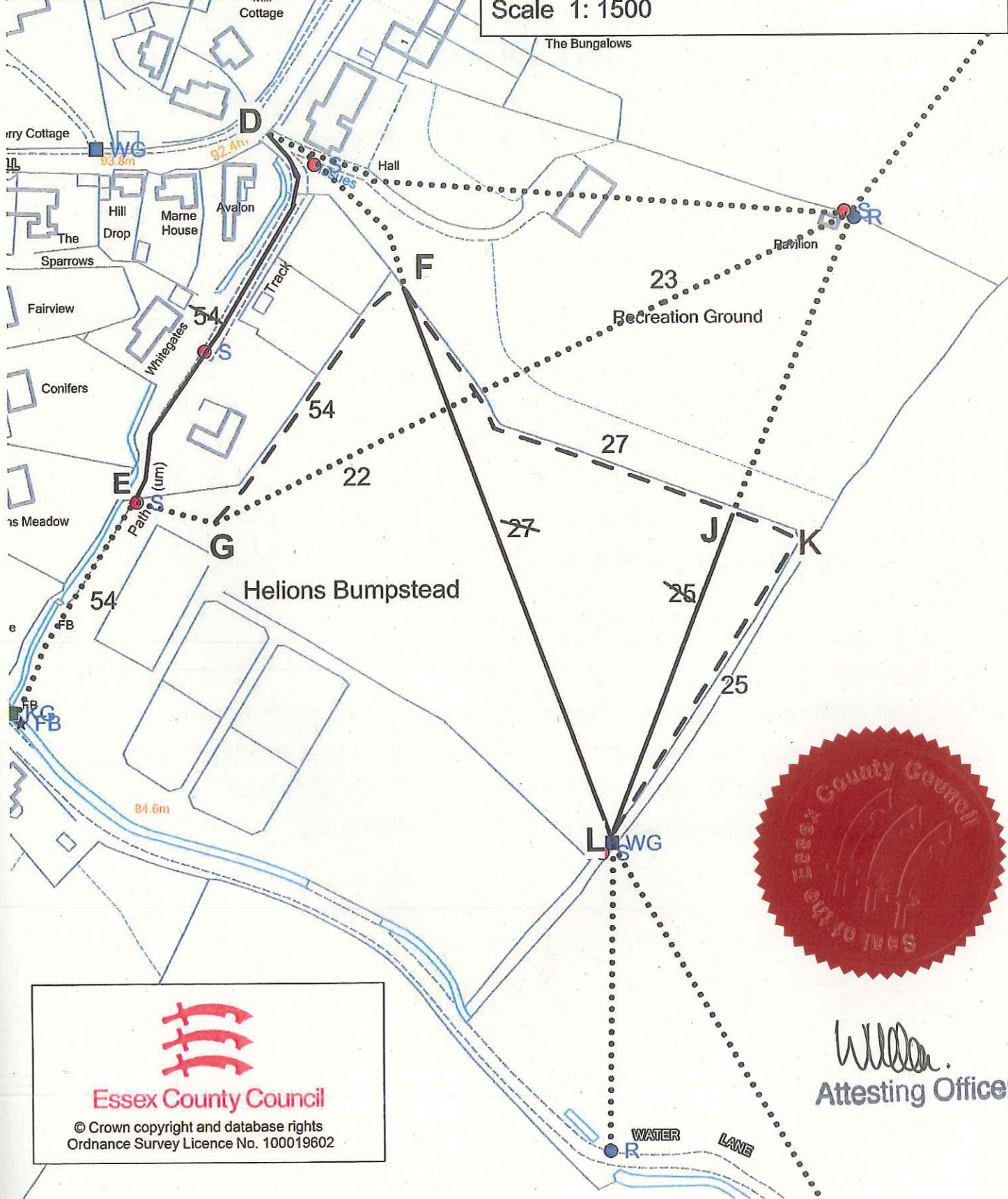
1. The public rights of way over the land situate at Helions Bumpstead known as Footpaths 25, 27 and 54 in the District of Braintree and shown by bold continuous lines on the map numbered HEB 54A contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 35 days from the date of confirmation of this Order.

2. At the end of 28 days from the date of confirmation of this Order there shall be public footpaths over the land situate at Helions Bumpstead described in Part 2 of the Schedule and shown by bold broken lines on the map numbered HEB 54A contained in this Order.

SCHEDULE

[PART 1] DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Footpath 54

A part length of Footpath 54 Helions Bumpstead of unknown width shown by a bold continuous line on the Order Map commencing from point **D** at grid reference 6521,4162 where it connects to the highway known as Church Hill running in a south easterly then a south westerly direction along the vehicular access drive to the property known as Whitegates for a total distance of approximately 128 metres to point **E** at grid reference 6517,4151 where it connects to Footpath 22 Helions Bumpstead.

Footpath 27

A part length of Footpath 27 Helions Bumpstead of unknown width shown by a bold continuous line on the Order Map commencing from point **F** at grid reference 6525,4157 at the stile on the field boundary running in a south easterly direction across the field for a total distance of approximately 175 metres to point **L** at grid reference 6532,4141 at the existing wicket gate on the field boundary.

Footpath 25

A part length of Footpath 25 Helions Bumpstead of unknown width shown by a bold continuous line on the Order Map commencing from point **J** at grid reference 6536,4150 running in a south westerly direction across the field for a total distance of approximately 105 metres to the aforementioned point **L**.

[PART 2]
DESCRIPTION OF SITE OF NEW PATH OR WAY

Footpath 54

A footpath being 2 metres in width shown by a bold broken line on the Order Map commencing at the aforementioned point F where it connects to Footpath 27 Helions Bumpstead running in a westerly then south westerly direction along the boundary fence for a total distance of approximately 135 metres to point G at grid reference 6520,4150 where it connects to Footpath 22 Helions Bumpstead.

Footpath 27

A footpath being 2 metres in width shown by a bold broken line on the Order Map commencing at the aforementioned point F running in a south easterly then an east south easterly direction along the field boundary for a total distance of approximately 125 metres to the aforementioned point J.

Footpath 25

A footpath being 2 metres in width shown by a bold broken line on the Order Map commencing at the aforementioned point J running in an east south easterly direction for a distance of approximately 20 metres to point K at grid reference 6537,4150 in the field corner then continuing in a south westerly direction along the field boundary for a further distance of approximately 104 metres to the aforementioned point L.
