Our impact assessments are produced by policy makers to consider the estimated costs and benefits of a policy when designing regulations. The Impact Assessment for Disability Living Allowance Reform outlines the estimated costs and benefits of introducing Personal Independence Payment for disabled people aged 16-64. The Department continues to carry out analysis of the likely impacts of its policies on protected groups, including disabled people. Impact assessments of policy changes are provided routinely, as required by the Equality Act 2010.
