Report on:	Provider Appraisal Update

### A. Introduction:

- 1. The Provider Appraisal directorate currently has three active assessments, and two decisions to be taken this month (Oxford University Hospitals NHS Trust and Royal Liverpool and Broadgreen University Hospitals NHS Trust). There are two ongoing transaction reviews.
- 2. There are no policy determining or strategic issues to report within this paper.

#### **B. Update on assessments**

3. A list of the NHS trusts currently with Monitor for assessment is provided in Annex 1. Any changes from the last report are highlighted in red.

#### Active assessments (exception reporting)

- 4. The Royal Liverpool and Broadgreen University Hospitals' application for NHS foundation trust status was deferred for a period of 12 months. The Oxford application is to be considered by the Board on 30 September 2015.
- 5. The assessment of Lincolnshire Community Healthcare NHS Trust commenced on 1 September 2015.
- 6. The assessments of Wirral Community NHS Trust and Norfolk Community Health and Care NHS Trust are ongoing, with the teams currently undertaking initial meetings with the trusts.

#### Assessment Pipeline

7. An overview of the assessment pipeline is provided in Annex 2.

## C. Update on transactions

8. The proposed merger between Ashford and St Peter's Hospital NHS Foundation Trust and Royal Surrey County Hospital NHS Foundation Trust has been given provisional clearance by the Competition and Markets Authority, with the final report expected in October 2015.

### Making a difference for patients:

Monitor's mission is to make the health sector work better for patients. This report provides an update on the Provider Appraisal team. The key focus of this team is to assess if providers are well led and can therefore deliver sustainable high quality services to patients.

### **Public Sector Equality Duty:**

It is not considered that there are any decisions within this paper which would impact on protected groups Identified by the Act.

#### **Exempt information:**

Some of the information in this report is exempt from publication under the Freedom of Information Act 2000.

The information is exempt as it falls under section 36 of the Freedom of Information Act 2000. Disclosure of that information would, or would be likely to, inhibit the free and frank provision of advice, or exchange of views for the purposes of deliberation. In applying these exemptions, we have considered the public interest test; disclosure of this information will not enhance the accountability or transparency of Monitor as its disclosure would inhibit the free frank disclosure of information.
