Release of Information

Thank you for your correspondence dated 13 January 2016 requesting the following information:

'I'm currently studying for a MSc and producing a report on the extent of outsourcing by the MOD to investigate the impact on training within the RN specifically. As such, this RFI is for statistical data to show the number of RN personnel who have been assigned to complement billets at HMS COLLINGWOOD since about 1995 if possible, so that I can compare how many there are in post now with how many there were since we started outsourcing much of the training services to civilian contractors.'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

I can confirm that the Department holds some of the information within the scope of your request and the summary for the period May 2007 – October 2015 is attached at Annex A to this letter. It should be noted that the information is only available from 2007 and data before this would pre-date JPA and therefore not give a reliable picture. The information in the response is derived from a Joint Personnel Administration (JPA) database report utilising 'COLLINGWOOD' or 'MWS' search terms and includes the location of the elements of the organisation.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
