## INDEPENDENT LIVING FUND GRANT DETERMINATION (2016-17) (No. 31/2818)

The Secretary of State for Communities and Local Government ('the Minister of State'), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination: 31/2818.

## **Citation**

1) This determination may be cited as the Independent Living Fund Grant Determination 2016-17 [No 31/2818].

#### Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them.

#### **Determination**

3) The Secretary of State determines as the authorities to which grant is to be paid, the authorities and the amounts set out in Annex A.

#### **Treasury consent**

4) Before making this determination in relation to local authorities in England, the Minister of State obtained the consent of the Treasury.
