## Dear

Thank you for your email of 1 April 2016 which requested the following information:

- 1) For each month between January and March 2016, and broken down between Iraq and Syria:
  - a) The number of Reaper, Tornado and Typhoon missions flown;
  - b) The number of Reaper, Tornado and Typhoon sorties with weapons released;
  - c) The number and type of weapons released by Reaper, Tornado and Typhoon.
- 2) The number of UK air strikes in Iraq and Syria per month from 1<sup>st</sup> January 2016 to March 2016 broken down between Reaper, Tornado and Typhoon aircraft.
- 3) Confirm if the UK armed forces have utilised US unmanned aircraft since 1<sup>st</sup> October and if so, the monthly number of sorties/ weapons releases?
- 4) If the figures are available, a monthly breakdown of number of aistrikes carried out by Reapers, Tornados and Typhoons using the UK method rather than the Coalition method since 1 October 2015.

Your correspondence has been treated as a request for information under the Freedom of Information Act 2000 (FOIA).

A search of records held by the Ministry of Defence has now been completed and we can confirm that some of the information within the scope of your request is held and answers to questions one and two is provided in the tables below. It should be noted

each Reaper mission count as one sortie, whereas Tornado and Typhoon missions consist of two aircraft and thus count as two sorties per mission.

Regarding your third question, the UK Reaper Force has not flown any US Air Force aircraft in support of operations in Iraq and Syria in the period in question.

Referencing your fourth question, as per the written statement provided to the House by the Secretary of State for Defence on 16 July 2015, we are to use Coalition produced numbers for UK strikes. As such, we haved ceased to produce strike data using the UK method and the information you requested on airstrikes from 1 October

2015 is not held. Further information on the decision to move to Coalition methodology can be found in the written statement at:

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
