Thank you for your letter of 23 October in which you requested the following information:

*“Of the aircraft flying at Wattisham, have any USA owned aircraft landed or taken off from its airfield in the last 12 months?”*

*Please list all aircraft types (including USAF, UK Government, private etc) that have landed or taken off from Wattisham in the last 12 months.*

*Are any experimental or developmental aircraft currently stored or operated from Wattisham airfield?”*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000. I am writing to confirm that MOD holds the information you have requested and this is shown below.

One USA owned aircraft landed at Wattisham in the last 12 months, this was a CV22 (Osprey).

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
