FOI - Royal Engineers NEMS Pay 16 Supplements

Annex A to Army Briefing Note 06/16 dated 7 January 2016 outlined the allocation of Army main trades for pay to NEM Trade Group Pay Supplements levels. For the Royal Engineer (RE) it reads:

1. Please can you confirm that this pay supplement allocation is correct. It appears that Military Engineer (ME) Trade Group 1 (e g Blacksmiths) are paid higher than ME Trade Group 3 (e.g Design Draftsman):

Answer: The pay supplement allocation is correct. RE trades were allocated to ME Trade Groups as per ABN 03/16 dated 7 Jan 16. Allocation of ME Trade Groups to pay supplements was primarily based upon a trades Through Career Whole Trade Score (TC WTS) which was calculated using Job Evaluation (JE) evidence. TC WTS and the JE process are explained in DIB 2016DIB/08.

The Annex A then breaks down the trades into specific employments which include:

35	Military Engineer – Combat	ME Trade Group 1	By the logic above would be Supplement 3
36	Military Engineer- Design Draftsman	ME Geo and Trade Group 3	By the logic above would be Supplement 2
38	Military Engineer - Driver	ME Trade Group 2	By the logic above would be Supplement 1

2. Please could you confirm which supplement the following individual who holds dual trade class qualifications as both a combat engineer and a military engineer driver would be paid at by completing the final column of this table:

Answer: A Military Engineer Driver is paid from ME Trade Group 2 and is therefore paid from Supplement 1. If an individual changes trade and they are employed in their new role; they are then to be paid from the Supplement which their new trade has been allocated. For those individuals who had dual employment qualifications prior to transition to Pay 16 an element of Military judgement had to be applied by the trade sponsor to decide which trade for pay an individual would be allocated based on their primary role.

3. If the Class of qualification is irrelevant in the allocation of pay supplement levels then please indicate in which circumstances a RE soldier would be paid at the Military Engineer Combat (Supplement 3) level rather than their trade allocated (e.g Military Engineer -Driver) Supplement level.

Answer: There are no dual trades under Pay 16. An individual's trade for pay is the trade group in which the person is primarily employed in and they can only have one trade at any one time. If an individual joins as a ME Engr Cbt they will remain in this trade unless they change trades. Completion of a Class 3 course does not entitle an individual to change trades. An individual will be placed in a trade group which is their primary role.
