- 2. What is the exact nature of the work conducted by Outside Organisation?
- 3. What are the terms of the contract between the SPA and Outside Organisation?
- 4. How long is the contract to run for?
- 5. How much has the SPA paid Outside Organisation from when they were commissioned by the SPA to the date of this request for information?

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that all of the information in scope of your request is held.

The information you have requested can be found enclosed below but some of the information falls entirely within the scope of the absolute exemption provided for at section 21 (Information Reasonably Accessible to the Applicant).

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
