 2* to be D HR whilst the civilian D HR was seconded to CTLB
- 2* Naval Base role not included as not funded by DE&S (see below too)

- Dir Ships post changed from Mil to Civ incumbent wef 2012 (+1)
- Dir Programme & Technology Group post abolished wef 2012 (-1)
- Dir Mat Strat post established wef 2012 (+1)
- Dir ISTAR post abolished wef 2013 (-1)
- Dir HR and COS posts merge wef 2014 (-1)
- Dir LCS post abolished wef 2015 post LCS-outsourcing (-1)

B1 and B2 Posts

- 2* NBOC post not included as not funded by DE&S
- NBOC Band B/OF5 staff not included as data not collected as part of wiring diagram and ABC13 exercise as agreed by COM(F) and DG Res

Ships

• No ABC13 return so assume Band B figures from 2013 wiring diagram and flatline
