# Introductory note

#### This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

The Industrial Emissions Directive (IED) was transposed in England on 27 February 2013 by the Environmental Permitting (England and Wales)(Amendment) Regulations (EPR) 2013. This variation implements changes brought about by the IED into this permit.

This facility treats non-hazardous waste with a capacity exceeding 75 tonnes per day involving biological treatment. The facility needs now to be permitted as an installation. This variation therefore changes the standard rules set that form the conditions of this permit from Standard Rules SR2008 No16 composting in open systems to Standard Rules SR2012 No8 composting in open systems.
