

$$\delta e (T, U, f) = \sqrt{(\delta e^2 (T, I, \cos\varphi), \delta e^2 (U, I, \cos\varphi), \delta e^2 (f, I, \cos\varphi))}$$

where

$\delta e(T, I, \cos \phi) =$	Additional error due to variation of the temperature at the same load
$\delta e(U, I, \cos \phi) =$	Additional error due to variation of the voltage at the same load
$\delta e(f, I, \cos \phi) =$	Additional error due to variation of the frequency at the same load
