Further information is the Scheme comprises hybrid application including full plans application for 'Urban Park' including remediation of land, access road and public realm works with associated landscaping/boundary treatment, and outline permission for mixed use development ('Urban pioneers') comprising residential(C3), business(B1), shop(A1), financial and professional services(A2), restaurant/cafe(A3), drinking establishment(A4) and non-residential institutions(D1). The associated works include sewer systems, infrastructure and enabling works.
