Thank you for your email on 7 January 2015 to the Ministry of Defence (MOD) requesting information on secondments. Your email has been treated as a request for information under the Freedom of Information Act 2000 (FOIA). You asked:

*"- The number of civil servants from your department seconded to work in the private sector, their ranks and the names of their private sector 'host' companies  
- The number of private sector 'secondees' to your department, the number of the companies from which they were seconded, their job titles on secondment, the branch/group/directorate in which they have been placed, the duration of their secondment, an indication of who is paying their salary during their period of secondment."*

A search for the information has now been completed within the MOD, and I can confirm that information in scope of your request is held in part and has been provided in Table 1 (Annex A) and Table 2 (Annex B) which are attached to this reply.

You asked for the job titles of those on secondment to the MOD. This information has been withheld under Section 40 of the FOIA as it is considered personal data under the Data Protection Act 1998, as it could be used to identify an individual.

Please note that the MOD Trading Funds (Defence Support Group, Defence Science and Technology Laboratory, United Kingdom, Hydrographic Office) have delegated authority over pay and personnel issues and information about their civilian staff would have to be sought directly from them.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1<sup>st</sup> Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail [CIO-FOI-IR@mod.uk](mailto:CIO-FOI-IR@mod.uk)). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
