## FREEDOM OF INFORMATION REQUEST TEMPORARY TRAFFIC REGULATION ORDER

Thank you for your email of 3 November requesting a copy of the Temporary Traffic Regulation Order that enabled us to close the A1307 near Cambridge, in both directions, over the weekend of 6/7 August. We have now completed our search for information.
