Notice of Outcome: Expression of Interest for Supplementary Matter Starts for Miscellaneous Work to deliver Legal Help relating to trafficking and modern day slavery compensation claims

The Legal Aid Agency ("LAA") has allocated matter starts to 31 Standard Civil Contract ("Contract") holders for Miscellaneous Work to deliver Legal Help for civil compensation claims arising in connection with trafficking and modern day slavery (the "Services").

On 15 December 2016, the LAA invited existing Contract holders to submit Expressions of Interest ("EOI") for Supplementary Matter Starts for Miscellaneous Work to deliver Legal Help relating to trafficking and modern day slavery compensation claims. Supplementary Matter Starts will be used to provide Services falling within the scope of paragraphs 32(2)-(3) and 32A(2)-(3) of Part 1 of Schedule 1 to the Legal Aid, Sentencing and Punishment of Offenders Act 2012.

Following the deadline for submission of EOIs on 12 January 2017, the LAA allocated matter starts to 31 Contract holders (see list below). Successful Contract holders have received 2 Supplementary Matter Starts for use by 31 March 2017 and 10 Supplementary Matter Starts for use from 1 April 2017 to 31 March 2018.

The number of Supplementary Matter Starts may be increased where demand for Services exceeds the initial allocation.
