Thank you for your email of 13 July in which you requested the following information:

- 1. Please state the amount spent by the MoD on providing boarding school education to children of service personnel, and the numbers of children that this related to for the 2015/16 financial year.
- 2. For the last financial year (2015/16) can you provide me with the numbers of children given such an education for each rank of the armed services?
- 3. For the last financial year (2015/16) please state how many children were educated at the following schools with the assistance of the Continuity of Education Allowance? (i) Eton, (ii) Winchester, (iii) Roedean, (iv) Fettes, (v) Radleigh, (vi) Wellington and (vii) Gordonstoun.
- 4. For the 2015/16 financial year please provide me with a list of the 25 schools where the MoD had the biggest spend in relation to the Continuity of Education Allowance. Please provide the name of the school and the amount the MoD spent at the school to provide, subsidised places for MoD employees' children.
- 5. What are the maximum that can be claimed annually under the various categories of the Continuity of Education Allowance?

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). I can confirm that the Ministry of Defence (MOD) does hold information within scope of your request.

I will answer each part of your request in order:

Q1. Please state the amount spent by the MoD on providing boarding school education to children of service personnel, and the numbers of children that this related to for the 2015/16 financial year.

Continuity of Education Allowance is provided to eligible Service Personnel (SP) to assist them in achieving continuity of education for their children that would otherwise be denied in the maintained day school sector if their children accompanied them on frequent and consecutive assignments.

The allowance may be claimed for service children from the beginning of the academic year in which they reach the age of 8 until the end of the stage of education during which they reach the age of 18 providing the Service Person meets the eligibility criteria. Continuity of Education Allowance claimants must be accompanied by their immediate family at their duty station and any child for whom Continuity of Education Allowance is claimed must complete the stage of education at the school for which the allowance has been claimed.

The idea is to ensure that service personnel are not disadvantaged by their service, whether keeping Britain safe at home or abroad, and this allowance ensures children with parents in the Armed Forces have educational continuity. A parental contribution for the boarding and tuition fees in respect of each child is required.

Continuity of Education Allowance was reviewed as part of the Strategic Defence and Security Review 2010 following which improvements in governance achieved a reduction of costs by around £30 million per annum along with an associated reduction in claimants. Work continues to reduce the cost of the allowance.

During FY15/16, Continuity of Education Allowance was paid in respect of 5,520 children at a total cost of £80.9M.

Q.2 For the last financial year (2015/16) can you provide me with the numbers of children given such an education for each rank of the armed services.

Continuity of Education Allowance is available to all service personnel, irrespective of rank, subject to them satisfying the eligibility criteria, the overarching principals of which are accompanied service and educational continuity. We are determined that it should go only to those who really need it, from our most junior service personnel to our most senior. Currently, the ratio between officer and other rank claimants is around 60:40.

During FY15/16, the numbers of children for whom Continuity of Education Allowance was claimed, by the rank of the claimants were as follows:

Q4. For the 2015/16 financial year please provide me with a list of the 25 schools where the MoD had the biggest spend in relation to the Continuity of Education Allowance. Please provide the name of the school and the amount the MoD spent at the school to provide, subsidised places for MoD employees' children.

Options for Service Personnel include a wide variety of schools across the United Kingdom from within the independent and state maintained sectors. In order to be admissible for the purposes of Continuity of Education Allowance, a school must offer full boarding facilities and be: registered with the appropriate UK education department; subject to Ofsted inspection and, in the case of independent schools, they must be a member of an organisation affiliated to the Independent Schools Council or the Scottish Council for Independent Schools.

During FY15/16 the 25 schools where spend on Continuity of Education Allowance was the greatest were as follows:

Q5. What are the maximum that can be claimed annually under the various categories of the Continuity of Education Allowance?

It is a condition of Continuity of Education Allowance that the claimant must make a <u>minimum</u> parental contribution of at least 10% of the boarding and tuition fees in respect of each child for whom they claim the allowance. Payment is capped with any fees beyond the allowance maximum being the responsibility of the parent. The maximum that may be claimed for each category of Continuity of Education Allowance are as follows:

Please note – In accordance with the Data Protection Act and our obligations in relation to the Protection of confidentiality when handling personal data, the figures provided have been rounded to the nearest 10, where "~" denotes a number less than or equal to five.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
