PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about dog import/export by AADR transport, which we received on 17 August 2016. Your request has been handled under the Freedom of Information Act 2000.

The information you requested and our response is detailed below:

“Under the freedom of information act could I request details of the numbers of dogs/puppies that AADR transport (under AA Dog rescue)

Oldfield lodge Burnham Road Latchingdon Essex

Have transported under traces and pet passports in the last 3 years into the UK

And also the amount of dogs that the fire mention may have transported out of the U.K.”

The table below provides figures for the numbers of dogs being transported into the United Kingdom by AADR Transport (under AA Dog Rescue).

Please note: APHA do not routinely record transporter details for dog imports or exports on local records so the only source for this data is from TRACES. Information that we have provided here from the TRACES system is a true reflection of the information that we have access to. APHA cannot guarantee the accuracy of this data, as we can only rely on the information that has been input into TRACES by a third party.
