Thank you for your request under the Freedom of Information Act of the 19th of January where you asked:

Please give me details of all NGO's and individuals you have made donations to who work in and run projects in Cambodia. This should include dates and amounts.

I understand the NGO called Action Pour Les Enfants is amongst these and would welcome confirmation or denile of this.

Please include not just donations/grants made directly from the UK but also those made by or through the British Embassy in Phnom Penh.

I am writing to confirm that we have now completed the search for the information which you requested for the last four years.

I can confirm that the Foreign and Commonwealth Office (FCO) does hold information relevant to your request. In Cambodia, the FCO funds projects carried out by NGOs through the British Embassy in Phnom Penh. When deciding the projects to fund the Embassy analyses how the project will contribute to FCO objectives in Cambodia; specifically, strengthening respect for human rights and democracy and supporting the work of the Extraordinary Chambers in the Courts of Cambodia (ECCC). The money spent fluctuates from year to year depending to the funding available.

The information that the FCO can release to you is attached.

The search found no record of a project funded by our Embassy in Phnom Penh and administered by Action Pour Les Enfants from April 2010 until this financial year.

In keeping with the spirit and effect of the Freedom of Information Act, all information is assumed to be releasable to the public unless it is exempt. The information we have supplied to you may now be published on our website together with any related information that will provide a key to its wider context.
