Welfare reforms Benefit Cap 2016 Background

The Welfare Reform and Work Act 2016 will introduce further significant changes to the welfare system aimed at simplifying the existing system and encouraging more people back into work.

The next phase of the Government's Welfare Reforms includes the expansion of the Benefit Cap.

The Benefit Cap will affect approximately 625 people in Cornwall.

The Government's Benefit Cap introduced a national limit on the amount of benefits a single person or family can receive.

From autumn 2016, the cap – outside of Greater London - will be:

- £384.62 per week (£20,000 a year) for a family or couple
- £384.62 per week (£20,000 a year) for a single person with children living with them
- £257.69 per week (£13,400 a year) for a single person

People of working age, between 16 and 64, who receive more than £384.62 as a family, or £257.69 as a single person a week in benefit, will have certain benefits reduced to keep their overall benefit below the new limit set by the Government.

The date the Benefit Cap will be introduced in Cornwall is currently anticipated to be November 2016, but this may change depending on the Government's roll out programme.

The cap applies to the total amount of people in a household, including partners and any children, which get from certain benefits including:

- Bereavement Allowance
- Carer's Allowance (currently applies to those affected by the Benefit Cap but won't from Autumn 2016)
- Child Benefit
- Child Tax Credit
- Employment and Support Allowance (unless you get the 'support' component)
- Guardian's Allowance (currently applies to those affected by the Benefit Cap but won't from Autumn 2016)
- Housing Benefit
- Incapacity Benefit
- Income Support
- Jobseeker's Allowance
- Maternity Allowance

- Severe Disablement Allowance
- Widowed Parent's Allowance
- Universal Credit (unless you aren't deemed fit for work)

People who are eligible for Working Tax Credit or Pension credit will not be affected by the cap, or if they or their partner work get Universal Credit, and their household income is more than £430 a month after tax and National Insurance.

Some benefits are not taken into account, and are exempt from the new benefit cap, including:

- Working Tax Credit
- Attendance Allowance
- Carer's Allowance (from Autumn 2016)
- Disability Living Allowance
- Guardian's Allowance (from Autumn 2016)
- Industrial Injuries Benefit
- Personal Independence Payment
- Employment and Support Allowance (support component)
- War Widow's or War Widower's Pension
- Armed Forces Compensation Scheme
- Armed Forces Independence Payment

Aims of the communications plan

- 1. The aim of the plan is to raise awareness of the changes being introduced through the Benefit Cap amongst people affected by the changes and stakeholder groups that work with them or represent them.
- 2. Prepare residents affected by the changes, and assist or signpost them to help, support, information and guidance.

Key messages

- The Government is introducing a limit to the amount of benefits some people can receive.
- This change is going to have a financial impact on approx. 625 residents of Cornwall.
- Cornwall Council and partners are very keen to help everyone affected by the Benefit Cap to ensure they receive the best possible assistance and guidance.
- Cornwall Council wants to engage with those affected by the changes to the Benefit Cap and any other welfare changes that have impacted on people and households.
- DWP has written, between 24 May and 9 June, to those they have identified as affected by the Benefit Cap.
- The Council cannot contact anyone until after 10 June 2016.
- Cornwall Council has an opportunity to deliver positive engagement with residents following the negative information provided by the DWP.
 Cornwall Council working with partners, is 'here to help'

Deliverable	Benefit Cap
Purpose	As part of the welfare reforms the Government is introducing a national cap on the amount of benefits a single person, couple or family can receive.
Key Elements	 Benefit will be reduced for people of working age. The cap is £384.62 per week for a family £384.62 per week for couples with or without children £257.69 per week for a single person The cap will not apply: To people who get pension credit or working tax credit To people who work a certain number of hours (tbc) per week If a member of the household is claiming Disability Living Allowance, Carers Allowance, Guardians Allowance, Attendance Allowance or the support element of Employment Support Allowance, Industrial Injuries Benefits (and equivalent payments as part of a war disablement pension or the Armed Forces Compensation Scheme), War Widow's or War Widower's Pension and Personal Independence Payment (From April 2013)
