## **DWP** response

(1) New Enterprise Allowance is available to claimants of Jobseekers Allowance (JSA), Employment Support Allowance (ESA) and lone parents claiming Income Support. Those claimants deemed suitable for participation in New Enterprise Allowance (NEA) are referred to start working with a NEA mentor by a Jobcentre Plus Work Coach - they do not apply for it.

The table below shows a regional breakdown of the number of mentor starts, where mentors have worked with unemployed people and other claimants to develop their business ideas between April 2011 and December 2013.

(2) The table below shows a regional breakdown of the number of NEA allowance starts between April 2011 and December 2013. The Department does not collect the number of trading starts centrally, however allowance starts provide an accurate proxy for the numbers which start to trade.

- (3&4) Data is not held centrally on the number of businesses that cease trading following access to the NEA allowance or the number of these who return to claiming benefits. However, an ad-hoc piece of analysis was published in July 2013 assessing the benefit status of NEA participants in the year after taking up the allowance. A regional breakdown of this information is unavailable but the analysis of 2,960 starts to the weekly allowance between April and December 2011 suggests that:
  - 78% of individuals were continuously off benefit for 52 weeks after their allowance start; the proportions at 13 and 26 weeks were 97% and 90% respectively. As discussed in the introduction, this is a highend *proxy* for sustained self-employment; there may be other reasons for remaining off benefit.
  - 85% of individuals were not in receipt of out-of-work benefits 52 weeks after starting the allowance; the proportions at 13 and 26 weeks were 97% and 91%.
