SU 9846 6051) and proceeding in a south easterly direction for 196 metres, to a line running from the same point and proceeding in a south easterly direction for 85 metres, then a south easterly then north easterly direction for 26 metres, then in a generally south south easterly direction for 107 metres as shown on the Order plan.
