Thank you for your request for information which we received on 11 February.

In your request you asked for;

British Embassy in Iceland. Annual report for 1991

Dispatches between the British Embassy in Iceland and FCO or other departments on the visit of Iceland's Foreign Minister, Jón Baldvin Hannibalsson, to the Baltic countries of Estonia, Latvia and Lithuania, in January 1991.

Dispatches between the British Embassy in Iceland and FCO or other departments on the decision by Iceland's Parliament on 11 february to reaffirm Iceland's 1922 recognition of the independence of Lithuania.

Dispatches between the British Embassy in Iceland and FCO or other departments on the the resumption of diplomatic relations between Iceland and the three Baltic states of Estonia, Latvia and Lithuania on 22 August 1991.

A small part of the information has been withheld (in 4, 6 and 16 above) under section 27 (2), which notes that information is exempt if it is confidential information obtained from a state other than the United Kingdom, or from an international organisation or international court. Where this was done has been clearly marked in the information released.

A small part of the reporting was information clearly given to us in strictest confidence, as opposed to routine diplomatic exchanges. Despite the age of the information, if the UK does not maintain this confidence it would reduce the trust of other governments, NGOs and others that they could hold free and frank discussions with us on sensitive issues. This would also reduce our ability to protect and promote UK interests in the future - both in Iceland and elsewhere.

Once an FOI request is answered, it is considered to be in the public domain. To promote transparency, we may now publish the response and any material released on <u>gov.uk</u> in the <u>FOI releases</u> section. All personal information in the letter will be removed before publishing.
