Thank you for your email of 16 February 2016 requesting the following information:

I would like to request under FOI details of MoD staff taking part in The Ministry of Defence Saudi Armed Forces Projects (MODSAP) on February 16, 2016 and in each previous year (with annual figures) broken down into

- a) military personnel (with further breakdown by service and rank if possible), and
- b) civilian MoD staff

I am treating your correspondence as a request for information in accordance with the Freedom of Information Act 2000 (FOIA).

A search for the information has been completed within the Ministry of Defence (MOD), and I can confirm that the MOD holds some of the information you have requested. Attached at Annex A to this letter is a spreadsheet which details the staff employed by the Ministry of Defence Saudi Armed Forces Projects (MODSAP) annually during the month of February, including the requested breakdown of military personnel. This information has been drawn from the service and civilian payrolls, but is only available for Financial Years 09/10 onwards. The totals may vary very slightly from the actual number employed on any single date during the month due to the usual churn of staff.

Under Section 16 (Advice and Assistance) of the FOIA you may want to note that MODSAP was established in 1986, but does not maintain its own personnel database and therefore relies on centrally-produced payroll data to meet requests for employee numbers. Previous requests have covered earlier years to those included at Annex A and I can therefore confirm the following additional information:

Note: The MOD no longer holds the information required to provide breakdowns of the military personnel totals.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
