AUTHORIZED AMENDMENT

Issue 8 to MAP-02 has introduced numerous structural changes to enable hosting and access via the external Gov.UK website. These changes have also been replicated on the MAA Defence Intranet site for consistency and ease of publication management. The new MAP-02 contains the same information as Issue 7.2, but the layout has changed as summarized below. Specific details are listed in Chapter 0.5 and the Regulated Community (RC) should familiarize themselves with these changes.

The following changes have been introduced:

1. Chapter 0.3 Preface. Introduction amended to include a description of the new structure and the method for accessing forms and formats.

2. Chapters 0.6 Individual Form/Format Changes and 0.7 Individual Form/Format Sponsor Changes. Content has been replaced by a signpost to tables on the MAA websites and a description for the new method of detailing form, format and sponsor changes.

3. Chapter 1.1 Catalogue of Forms - General. Introduction updated to reflect the new style of presentation and details added for the promulgation of new and revised forms.

4. Chapters 1.2 to 1.7 Catalogue of Forms. Content has been replaced by a signpost to hyperlinked tables on the MAA websites. Form versions remain unchanged.

5. Chapter 1.8 Catalogue of Formats. Content has been replaced by a signpost to hyperlinked tables on the MAA websites. Format versions remain unchanged. Chapter 1.8 is now displayed in the same manner as Chapters 1.2-1.7. Additional columns added include Retention Category when printed, Sponsor and Comments.

6. Chapter 2.1 Instructions For Use - General. Outline has been updated to reflect the new style of presentation. Amendment procedure aligned with Chapter 0.3.

7. Chapter 5 Specific Platform Indexes. Content has been replaced by a signpost to hyperlinked tables on the MAA websites. Form versions remain unchanged.
