# Purpose of the statistics

#### Context of the statistics

DWP publishes regular quarterly National Statistics on the number of people claiming working age benefits. These statistics are published for a range of claimant characteristics including gender, age, and in some instances ethnicity.

Data on nationality is not routinely published as the source systems used to capture and process benefit claims, typically do not include a nationality marker.

However, DWP does publish separate official statistics on the number of National Insurance Numbers (NINo) registered to non-UK nationals entering the UK. Again, these statistics are published by gender, age - and by nationality.

In the absence of nationality markers on the benefit computer systems, linking these datasets provides an **estimate** of the number of DWP working age benefit claimants within Great Britain, who **at the time they registered for a NINo were non-UK nationals.** 

## Purpose of the statistics

The department releases annual official statistics (in August) on "<u>Nationality at point of National Insurance Number registration of DWP working age benefit claimants</u>". This ad hoc provides a breakdown for Wales not currently included in the existing routine publication.

This follows a request from the Welsh Assembly for this information.

#### Results

Non-UK nationals at NINo registration: DWP working age benefit claimants in Wales, Feb-16

Total	7,670
European Union	2,820
Non-European Union	4,390

Note – there are a small number of claimants where nationality is recorded as unknown.

### Limitations of the statistics

These statistics do not provide a measure of non-UK nationals currently claiming benefits based on their current nationality. The statistics do provide an **estimate** of the number of people currently claiming benefit who, when they first registered for a NINo, were non-UK nationals.

Analysis **excludes** Universal Credit, Housing Benefit and HMRC in-work benefits such as Tax Credits and Child Benefit

## Source of the statistics

The following sources of administrative data were used to support this publication:

- HMRC National Insurance Pay as you Earn System this provides a list of National Insurance Number assigned following application (as opposed to automatic allocation), along with accompanying information on the date of arrival, registration, and nationality at the time of registration.
- The work and pensions Longitudinal Study A 100% quarterly extract of Departmental administrative data, used here to attribute working age benefit claimants.

Estimates have been produced by using an individual's National Insurance Number to match the nationality record for non-UK nationals registering for a NINo, to DWP working age benefit claimants.

## Definitions and terminology within the statistics

Benefit claimants are those recorded on the administrative system at the reference date (February 16)

The working age benefits included are as follows:

- Jobseeker's Allowance
- Employment and Support Allowance, Incapacity Benefit and Severe Disablement Allowance
- Income Support / Pension Credit
- Carer's Allowance
- Disability Living Allowance and Personal Independence Payments
- Widow's Benefit

European Union includes: Austria, Belgium, Denmark, Finland, France, Germany, Greece, Ireland, Italy, Luxembourg, Netherlands, Portugal, Spain, Sweden, Bulgaria, Romania, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Poland, Slovakia, Slovenia, Croatia, Cyprus, Malta
