Thanks so much for talking to me just now. **You kindly said you would be able to share with us the contact at the Home Office who has put together the list of experts (QCs and others) who might replace Butler-Sloss.** We are very much looking for a similar person who can lead our independent review into whether there was a conspiracy to cover up child abuse on St Helena – involving HMG, the Saint Helena Government and the police and social services on the island. The people who are making these allegations are two former social workers who are also bringing employment tribunals against FCO and DFID (although they weren't our employees officially) and they also have an investigation going on into their behaviour at the moment as they have been accused of perjury.

The reason we think we urgently need a QC for the independent investigation into conspiracy is because we need to de-conflict the three investigations. I would also be very grateful for any advice you have to CO lawyers/team who may be able to give us advice on making these investigations very separate as well as the list of names who might be able to lead the investigation.

### DOCUMENT NO 3

*This paragraph comes from a submission to the Permanent Under Secretary and Minister James Duddridge, written by Martin Longden (head of Falklands, Southern Oceans and British Indian Oceans Territory) on 11 September 2014.*

5. Following guidance from Ministers, officials have engaged with Ms. Sasha Wass QC, a pre-eminent and high profile barrister with an expertise in child safety issues to establish whether she would be prepared to lead this independent inquiry into child abuse on the island. Ms. Wass has now confirmed that she is content to take this on. This is a very positive development: Ms Wass is well respected and highly competent, and will give credibility to the inquiry as well as professional rigour. We recommend that Ministers commission her accordingly.

### **“ANOTHER CHILD ABUSE COVER UP IN PROCESS – THE WASS INQUIRY (ST HELENA) – DFID - FCO EXPOSED AGAIN”**

Thank you for your email of 16 July on the above subject.

HMG is taking child abuse allegations on St Helena very seriously. In his Written Ministerial Statement (WMS) of 20 November 2014, the Foreign Secretary stated, “I have agreed that Ms. Sasha Wass QC should lead this Inquiry. Ms. Wass is a very accomplished barrister with substantial professional experience of dealing with these kinds of issues. I am confident that she will lead this Inquiry with great rigour, fairness and sensitivity”. The Foreign Secretary added, “This new Inquiry will not be quick. But it will be thorough. And I am confident that the facts will be established”.

Ms Wass QC has extensive experience in sex cases both as a member of the independent criminal bar and as a judge.

We note that Ms Wass has not been instructed by, nor received any fees from DFID, either in relation to the Ibori case or any other matter.

The Foreign and Commonwealth Office remain confident in the independence of Ms Wass, that she is experienced and qualified to chair the Inquiry, and we are satisfied that there is no conflict of interest.

We await Ms Wass’ report and will be responding to her findings and recommendations.
